YOUR AGREEMENT WITH GCDC

I understand that the Spring Show is OPTIONAL. In order for my daughter to participate in the April 26, 2020 show, I understand that she must:

- Attend all mandatory rehearsals in their entirety. ALL dancers attend rehearsal on Friday, April 24 and one or two other rehearsals on April 22 or 23. I will keep all dates open until specifics are given in February or March.
- Comply fully with the dress code set for her class and pay the non-refundable show fee of \$75 by January 6.
- Make attendance a priority and I agree to pay for a private lesson (\$5/half hour) if she misses two classes in a row or any class January-April.
- I understand that siblings may be assigned to perform in different show times (if applicable) and that separate tickets would need to be purchased in that event.
- Show videos of the dancers will be made available for purchase by parents. Videos are property of GCDC and individual songs may be posted on social media without my consent. (Your child will not be named.)
